Sale of 5% beer and wine by the drink at retail for consumption on the premises.

PACKAGE LIQUOR – 5% BEER (Monday through Sunday)

Sale of 5% Beer at retail in the original package not for consumption on the premises where sold.

LIQUOR BY THE DRINK – 3.2% BEER (Monday through Sunday)

Sale of 3.2% by the drink at retail for consumption on the premises.

PACKAGE LIQUOR – 3.2% BEER (Monday through Sunday)

Sale of 3.2% Beer at retail in the original package not for consumption on the premises where sold.

**TEMPORARY PERMITS – BY THE DRINK FOR CERTAIN ORGANIZATIONS
